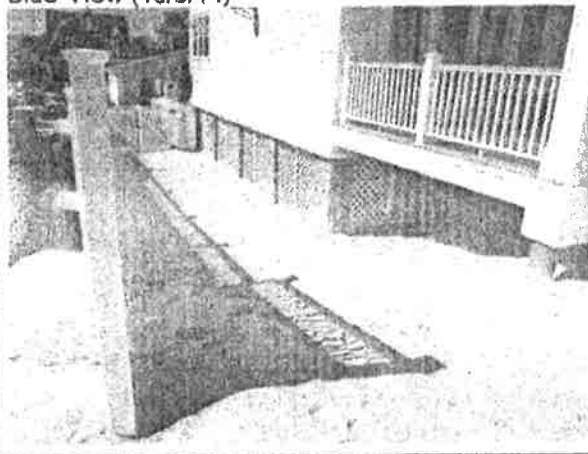
Front View (10/3/14)



Rear View (10/3/14)

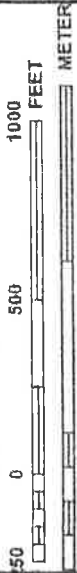


Side View (10/3/14)

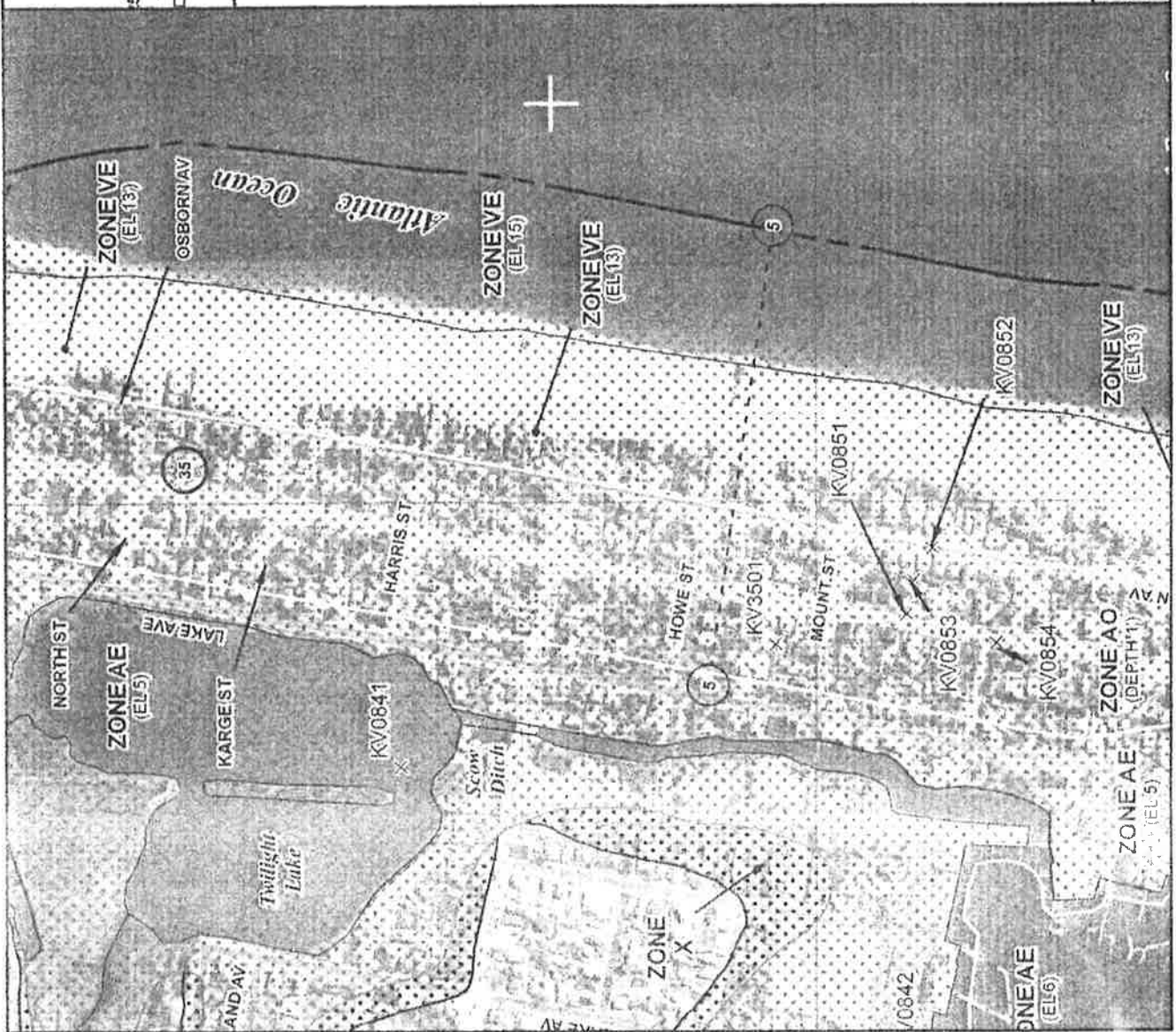

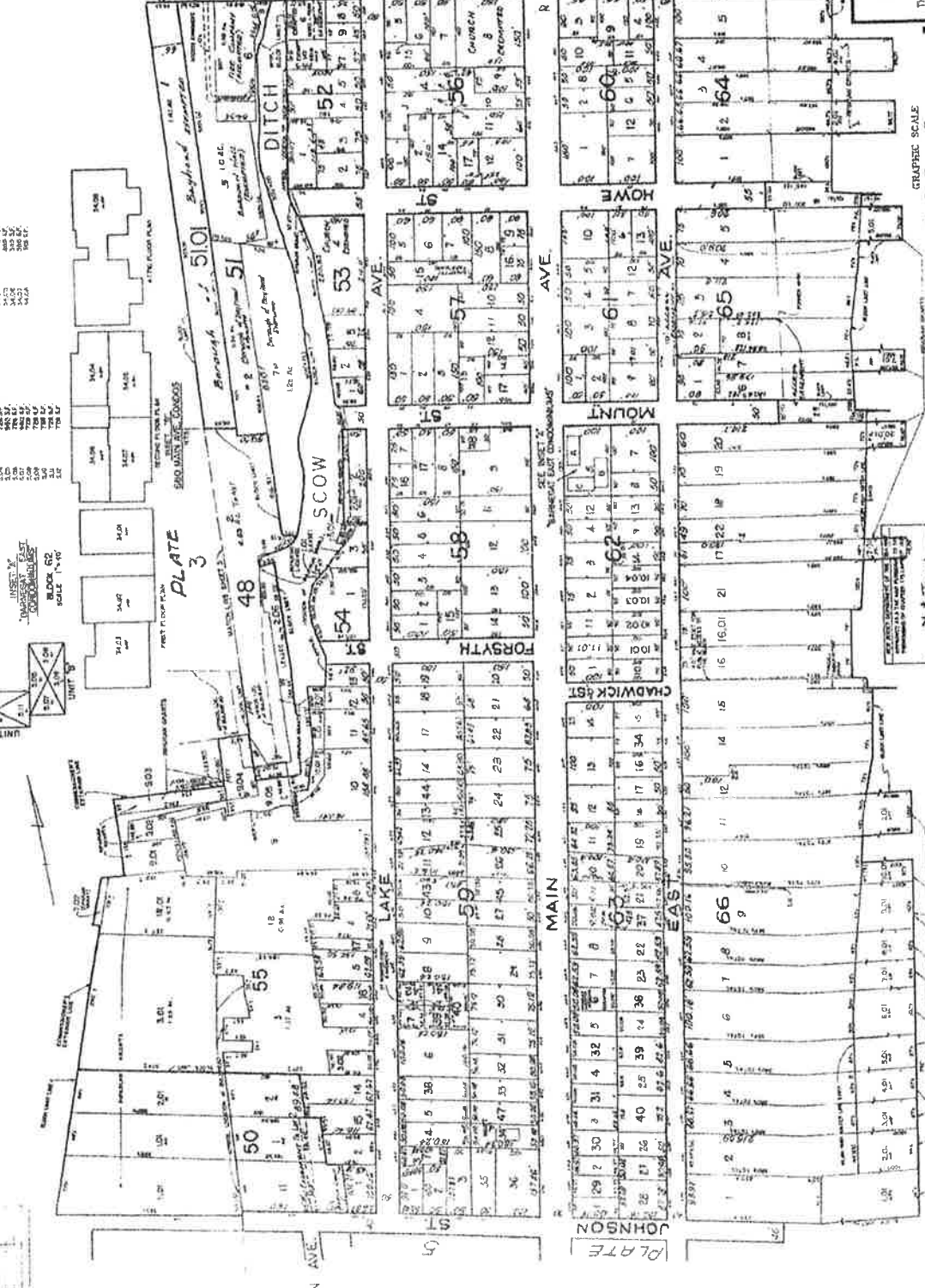
